PERMISSION AND WAIVER FORM FOR STUDENT DEPARTURE AT LUNCH HOUR – GRADES 10, 11 & 12

The hours of the instruction day of Crestwood Preparatory College ("Crestwood") are from 8:35 a.m. to 3:10 p.m. The lunch period for the Grade 7 and 8 students is from 11:30 a.m. to 12:25 p.m. The lunch period for the Grade 9, 10, 11 and 12 students is from 12:25 to 1:20 p.m. Grades 7, 8 and 9 are not allowed to leave school premises during lunch. **In general, all students are encouraged to stay on school premises over the lunch period.** However, some students in grades 10, 11 and 12 may depart from school premises over the lunch hour. Crestwood recognizes that there is an inherent element of risk for students who depart from the school premises during the lunch period. The nature and degree of the risk will, of course, depend on the destination of the student, who they meet and their related activities.

During the lunch period, Crestwood provides supervision for students who remain on school premises. In the event that a student leaves the Crestwood premises during the lunch period, incidents may occur and injuries may result through no fault of the school. Students and/or their parents must assume these risks.

In the event you would like to give permission for your son/daughter to depart from school premises during the lunch period, Crestwood requires that you sign the attached permission and waiver form and your son/daughter also sign the attached form. Crestwood is a place that promotes responsibility, respect, civility and academic excellence in a safe learning and teaching environment. Crestwood makes every effort to ensure that its students are safe, and feel safe, in the school community.
