Course Fees: \$1450.00 (\$750.00 for one half credit)

Registration Fee: \$95.00 for all non - CPC students.

All fees will be refunded if a course is not offered due to insufficient enrolment.

A **Deposit of \$450.00 (\$300.00 for one half credit course)** plus registration fees if applicable must accompany the registration form and is due **by May 30th, 2017**. This deposit and registration fee is non-refundable.

The **balance of \$1000.00 (\$450.00 for one half credit) is due on June 6th, 2017**. Any student withdrawing from a course after this date will not receive any refund.

A student may not begin a course until all payments have been made in full.

Course Materials: Students are responsible for all required textbooks. These will be sent to the students in early June.
